Introduction

Amsshare values the protection of your personal data. In this privacy statement, we explain how we handle personal data processed in the context of our services. Amsshare processes personal data in accordance with the General Data Protection Regulation (GDPR).

1. What data do we process?

Amsshare processes the following types of personal data:

- Name and contact details (such as email address and phone number).
- Business information, such as job title and company name.
- Data about your activities on our website.
- Technical data such as IP addresses or browser information, if necessary for delivering our services.

2. How do we collect data?

We collect personal data in the following ways:

- Through correspondence, such as email.
- Through forms on our website.
- Automatically through the use of our website (e.g., via cookies).

We process this data based on the following legal grounds:

- Consent, if you have given us permission.
- Necessary for the performance of a contract, where applicable.

3. Purpose of data processing

We process personal data solely for the following purposes:

- To provide our services.
- To maintain contact with our clients and business relations.
- To improve our website and services through analytical data.
- For marketing purposes, such as sending newsletters. You can opt out of such communications at any time.

4. With whom do we share your data?

We do not share personal data with third parties unless it is necessary for the performance of our services or to comply with legal obligations. In such cases, we only work with trusted partners and ensure that they take appropriate security measures.

If data is transferred to countries outside the European Economic Area (EEA), we ensure that this is done in accordance with the GDPR and with adequate safeguards.

5. How long do we retain your data?

We do not retain personal data longer than necessary for the purposes mentioned above, or as legally required. The retention period may vary depending on the nature of the information and legal obligations.

6. Your rights

You have several rights regarding your personal data:

- **Right of access:** You can ask us what data we process about you.
- Right of correction: You can request to correct inaccurate data.
- **Right to deletion:** You can request the deletion of your data.
- **Right to restrict processing:** You can request to limit the processing of your data.
- **Right to data portability:** You can ask us to transfer your data in a structured format.

If you wish to exercise any of these rights, you can contact us using the above contact details.

7. Security of your data

Amsshare takes appropriate technical and organizational measures to protect your data from unauthorized access, loss, or theft. This includes the use of secure connections (such as SSL) and access security for our systems. In the event of a data breach, we follow the legal notification obligation as required by the GDPR.

8. Cookies

Amsshare uses functional, analytical and tracking cookies. A cookie is a small text file that is stored in the browser of your computer, tablet or smartphone during your first visit to this website. Amsshare uses cookies with purely technical functionality. These ensure that the website functions properly and that, for example, your preferred settings are remembered. These cookies are also used to make the website work efficiently and to optimize it. Additionally, we place cookies that track your browsing behavior so that we can offer tailored content and advertisements.

During your first visit to our website, we informed you about these cookies and asked for your permission to place them.

You can opt out of cookies by setting your internet browser so that it no longer stores cookies. Additionally, you can also delete all previously stored information through your browser settings.
